| Controlling High Blood Pressure | Screening for High Blood Pressure** | \$60 | Members 18–85 years of age who had a diagnosis of hypertension (HTN) and whose BP was adequately controlled (<140/90 mm Hg) during the measurement year. |
| Colorectal Cancer Screening | Screening for Colorectal Cancer | \$50 | Members 45-75 years of age who had appropriate screening for colorectal cancer using one of the following criteria: <ul style="list-style-type: none"> • Fecal occult blood test during the measurement year • Flexible sigmoidoscopy in the last 5 years • Colonoscopy in the last 10 years • CT colonography in the last 5 years • FIT-DNA test in the last 3 years |
| Annual Dental Visit | Dental Screening | \$50 | Members 21 years of age and older who had at least one dental visit with a dental practitioner during the measurement year. |

| Medication Adherence for Diabetes Medications | Prescription Refill** | \$100 | Members with a prescription for diabetes medication who filled their prescription often enough to cover 80% or more of the time they are supposed to be taking the medication. |

| Transitions of Care-Medication Reconciliation Post-Discharge | Medication Reconciliation | \$50 | Members 18 years of age and older who were discharged for an acute or nonacute inpatient admission and had documentation of medication reconciliation on the date of discharge through 30 days after discharge (31 total days). |

** Incentive is paid if the member is adherent to their medications or blood pressure or HbA1c level is controlled as of December 31, 2024.
