Asthma Program

We strive to improve preventive care for children and adolescents with asthma by partnering and increasing collaboration with providers. Meridian's new asthma program helps members identified as having asthma manage and understand their symptoms through education and outreach.

J&B Medical Supply Partnership

To assist in the collection of diabetes-related Healthcare Effectiveness Data and Information Set (HEDIS®) measurements, MeridianHealth partnered with J&B Medical Supply (J&B) to provide members with home blood glucose testing, continuous glucose monitoring, and insulin pump supplies. J&B will send a simple prescription form asking for diabetes HEDIS® supplemental data, including the most recent information from the following screenings: HbA1c, LDL, dilated eye exam, microalbumin, blood pressure, and BMI. Risk for Continued Opioid Use Program

The Risk for Continued Opioid Use (COU) program launched in October 2019. This program focuses on providing opioidnaive members with educational materials on the potential risks of opioid use over time, and how to safely dispose of opioid medications to prevent misuse. An additional member focused telephonic component of this initiative launched on February 1, 2020.

Michigan Department of Health and Human Services Healthy Michigan Plan (HMP) Exemption Information

Beginning January 1, 2020, HMP members who are considered medically frail are exempt from the 80 hours of work requirements to maintain healthcare coverage. Michigan Department of Health and Human Services (MDHHS) will review healthcare claims within the CHAMPS system and identify members considered medically frail. This review will take place within a 12-month window from the presence of select diagnosis codes. These diagnosis codes can be found here:

Providers will be able to recommend that members are considered medically frail through clinical judgement in cases where members have not self-identified with MDHHS.

2020 Michigan Common Formulary Update

On March 1, 2020, MeridianHealth will change coverage for Naproxen 275 mg tablets and Naproxen 550 mg tablets to align with the Michigan Department of Health and Human Services (MDHHS) common formulary. Alternatives for these medications are Naproxen 250 mg tablet, Naproxen 375 mg tablet, Naproxen 500 mg tablet, and others.
